Welcome Back to Bucknell - Amplify Your Impact!


Thanks to those who attended the Freeman College Student Advisory Board hosted Welcome Back luncheon and prize giveaway on

MANAGEMENT IN ASIA-PACIFIC Study and Internship Abroad

The semester long program begins in January with students spending eight weeks in Sydney, Australia taking four classes that include two Management core accounting and finance courses and two other courses which may satisfy CCC requirements. The remaining eight weeks of the semester, students will participate in a business internship in either Sydney or Singapore. What an amazing resume building opportunity!

Open to all majors across all colleges, this program is particularly well suited to Accounting and Finance majors, as it offers Business Law (ACFM 201) and Financial Decision Modeling (ANOP 302). All students interested in taking ANOP 302 must complete the proper pre-requisites (ANOP 102 and either ACFM 203 or ACFM 210).

Sydney – take four courses

- Business Law (ACFM 201)
 - Financial Decision
 - Modeling (ANOP 302) Two additional courses

Spend eight weeks in Sydney or Singapore participate in a business internship

 Intercultural Management (MGMT 290)

Additional Management course options will be offered.

The program includes a one-week spring break trip to Cairns, Australia where students will snorkel or dive in the Great Barrier Reef, visit the rainforest and waterfalls and spend time at Fitzroy Island.



Professor Stanciu joined Bucknell in 2007. She has leveraged her expertise in the areas of Operations Research and Business Analytics as well as through her Bucknell-Geisinger research grants to inform and guide her teaching of Business Analytics. Her scholarship has enriched her lectures with real-life examples that immediately pique her students' interest in not only Business Analytics but also other disciplines. Students comment on her ability to connect the course topics – which some may consider rather dry – to real decisions that impact the industry, current events, and the personal lives of us all.
